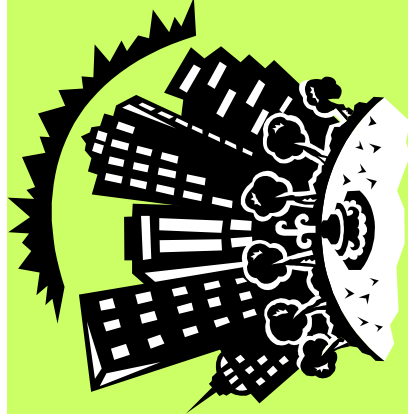

CSH 2008 Supportive Housing Training Calendar

The Corporation for Supportive Housing (CSH) proudly presents its Supportive Housing Training Calendar for 2008. This year CSH will be providing four (4) training tracks to meet every skill level. We encourage all participants to register for an entire track of trainings.

Track 1: ***Intro to Supportive Housing***

#1: Supportive Housing 101

March 11, 2008—Full Day Training

Learn the basics of supportive housing development from project concept to budget development through construction and lease up.

#2: HUD 101

April 8, 2008—Full Day Training

Designed for agencies with McKinney Vento programs. Learn how to execute HUD paperwork, eligibility and program standards and basic record keeping and monitoring. Great for new staff or as a brush up for those involved in the HUD process.

#3: Models for Service Delivery

July 15, 2008

Panel discussion on supportive housing service delivery models. Providers in the field will touch upon on-site services, service coordination, partnering for services, and delivering voluntary services.

Track 2: ***Supportive Housing 202***

#1: Land Use Issues

April 29, 2008

Learn how to survive the zoning process including what you need to know to determine project feasibility and location. Understand how local, state, and regional regulations may affect your supportive housing project.

#2: Issues in the First Year of Operations

May 9, 2008

You have started a new permanent supportive housing project – now what? Presenters will provide insight on all aspects of operation in a projects first year and how to be prepared for common issues that arise.

#3: Working with For-Profit Developers

December 9, 2008

Panel discussion with for-profit developers on how non-profit service/housing providers and for-profit housing developers can work together to create permanent supportive housing.

Track 3: ***Capacity Building***

#1: Building the Foundation: Board & Staff Development

June 17, 2008

Gain tools to educate your Board and staff about permanent supportive housing and build capacity from the inside for housing development. Understand the skill base your agency must have to create successful supportive housing projects.

#2: Beyond the Single Family Home – Developing and Financing Larger SH Projects

September 9, 2008

Move your development ability beyond the single-family home. Panel discussion on the development process and funding mechanisms available to create larger supportive housing projects and best practices.

#3: Integrated Housing Models

October 14, 2008

Learn the latest in integrated supportive housing models included mixed income and supportive housing, and integration of different special needs populations within one project. Presenters will present information on how to develop projects and best practices.

Track 4: ***Focus on Populations***

#1: Serving Youth in Permanent Supportive Housing

June 24, 2008

Experienced providers present on how to develop, operate and provide services for permanent supportive housing projects for youth.

#2: Serving Families in Permanent Supportive Housing

August 12, 2008

Experienced providers present on how to develop, operate and provide services for permanent supportive housing projects for families.

#3 Serving the Re-Entry Population in Permanent Supportive Housing

November 6, 2008

Experienced providers present on how to develop, operate and provide services for permanent supportive housing projects for the re-entry population.
