



#### How Long Did It Take To "Get There???"

- Launched effort in September 2016
- 50+/- community meetings/community events to "hear the voices of the community"
- 1000+ cumulative hours spent in:
  - discussion/digestion/synthesizing/do cumenting and then....
  - drafting a report, getting feedback on draft and then finalizing
- Final Report produced, shared locally and forwarded to HUD in June 2018



#### Then What????



Asbury's CHOICE award was 1 of only 10 planning grants awarded nationwide by HUD.... Implementation Grants even tougher to come by.....

Disappointing but elements of Plan have been implemented.... Some examples of "Bricks-and-Mortar" projects that have been developed....

- APHA redeveloped Boston Way Village
- Interfaith Neighbors developed
  *Parkview AP* a mixed income homeownership project

#### Parkview AP Residences

Construct the Parkview AP Residences, a planned homeownership development by Interfaith Neighbors

The duplex homeownership model incorporates a live-in unit and a rental unit, creating an additional income strear for the homeowner. Many Lincoln Village and West Side residents have expressed the desire to buy a home.

# Millions of \$\$\$\$ needed – but not awarded – for Bricks-and-Mortar so....

Increased focus on Programming to benefit West Side residents

- Expand financial assistance programs
- Spread health information through expanded Mayor's Wellness Committee
- Increase availability of dental treatment
- Expand quality pre-school programs
- Expand life skills programs/workforce development programs, career advancement programs
- Focus on "skill collar" jobs
- Expand summer programming for youth and PAL offerings
- Expand Re-Entry programs

Enhance security at APHA properties

#### Let's showcase one current initiative APHA and IFN are working on....

- Food Security and Food Choices for Better Health
  - 1. Fresh Food for Older Adults: All free, fresh local organic food distribution, led by residents, at two different APHA properties (Lumley and Robinson), every Monday.
  - 2. Fresh Food for Families: All free, fresh local organic weekly food distribution for families, starting in October, at Boston Way.
  - 3. Develop and offer plant-based cooking classes (coming in December).
  - 4. Future: Food in Housing Organizing Effort: 2024. Creating community committees to determine food needs, transportation challenges, cooperative purchasing, etc.
